Bidders are advised to make the following revisions to the Proposal:

- 1. Replace, in the Proposal, on page 254, the first sentence in Section 3.19 of the Special Provision for Item 616.451 Traffic Signals Removal and Reinstallation with the following sentence: "Remove and reinstall only those portions of the existing traffic signals that the Contractor has determined need removal to facilitate the deck replacement operations".
- 2. Replace, in the Proposal, on page 9, Item 1 of the Prosecution of Work section entitled "Maintenance of Traffic" and, on page 14, Item 3 of the Traffic Control Plan section entitled "Maintenance of Traffic" with the following item:
 - 3. The NB and SB bridges at Exit 14 will (alternately) be closed on non-consecutive weekends beginning Friday, April 2, 2010 at 7:00 PM through Monday, May 24, 2010 at 7:00 AM for the construction of the deck replacement.  - i. Southbound Bridge Construction
 - 1. During the nighttime barrier shift, NB traffic may be detoured to the NB ramps with officer control at the ramp intersections with Loudon Road, Maintain 1 lane SB on I-93 across the bridge.
 - ii. Northbound Bridge Construction

- 1. During the nighttime barrier shift, SB traffic may be detoured to the SB ramps with officer control at the ramp intersections with Loudon Road. Maintain 1 lane NB on I-93 across the bridge

- d. Sunday 10:00 PM to Monday 7:00 AM Remove barrier
