In Article 1102.01 of the Standard Specification, the formula MAXPREQ (maximum prequalification amount) limitation is removed for bidders with a CPA Reviewed Statement or a CPA Audited Statement. Contractors may be approved for awards exceeding their maximum prequalification amount.

The contractor is not relieved of any other contract requirement. The prime must still self perform the required minimum contract percentage, and must possess all necessary licenses, certificates and resources to do so. A proposal guaranty, performance bond and insurance are still required. The bidder may be required to furnish evidence to the satisfaction of the Department of Transportation of their ability to perform and complete the work before being allowed to bid. The Department maintains the right to determine valid eligible bidders.
